**JUST CLEAN FUEL, LLC** agrees to render 24 HOUR service on "no heat" calls and to service your oil burner in accordance with the following plan.

**PLAN:** For the sum of \$ 238.50 which includes applicable taxes, per year, payable in advance, we will provide the following service and/or repairs. We will repair or replace (at our discretion) the following oil burner parts (if defective due to normal wear) at no extra cost. One cleaning per contract period is included at no charge if you schedule the cleaning to take place between April 1<sup>st</sup> and September 30<sup>th</sup>. If you schedule your cleaning to take place between October 1<sup>st</sup> and March 31<sup>st</sup>, there will be an additional charge for the cleaning. A description of our contract and parts covered is below. Labor coverage for installing the parts listed below will be 24 hours a day (for no heat calls), 365 days a year. - \* This contract does not include the replacement of obsolete parts which are not readily obtainable from our normal suppliers. Obsolete parts may be replaced with comparable parts. Equipment must be accessible for service and or repairs.
- \* No refund shall be given if this contract is canceled. This contract, as written and without revision, shall be transferable to the new homeowner should the customer's home be sold.
