This will include testing for leaks, relays, capacitors, contactors, circuit boards. (if available) **(REPLACEMENT LABOR ONLY FOR COMPRESSOR AND COIL).** The cost of refrigerant will be extra. (R22 and 410A) \$158.46 (including tax)

3. It is the policyholder's responsibility to be sure the oil tank(s) do not run out of oil. In the event of a service call due to oil run out, you will be charged the standard rate for the call.
4. RLD Heating & Cooling, Inc. reserves the right of coverage to normal wear and tear of the heating unit(s). Damages that occur in the event of extreme circumstances, are abusive in nature, and/or an act of nature beyond control are not covered, but may be covered by home owner's insurance. In such situations, RLD will respond to the best of the company's ability.
5. RLD Heating & Cooling, Inc. is a full service company providing high efficiency heating and cooling products. Should you require repair, replacement, or upgrade of your system, a complete job quote can be submitted for you approval.
