## **AUTOMATIC DELIVERY AGREEMENT**

The customer will pay for the heating oil delivered to the address below, in accordance with the terms and conditions set forth in this agreement. *Tank vent alarms must be working at all times without exception.* 

## **Terms of Agreement:**

- Just Clean Fuel, LLC will deliver the heating oil to the address listed below and is not responsible for any
  problem with the heating system, oil tank, fill, and vent piping. <u>All vent alarms (whistles) must be in working</u>
  order at all times at customer's expense.
- 2. Every account with a Heating Oil price contract or agreement must participate in the Automatic delivery program. Any price contract, reserved gallons, or addendums associated with a written contract must be delivered prior to any other fuel pricing or programs become effective. All deliveries after a contract expires or reserved gallons are used up will be priced at Just Clean Fuel's posted daily low price for automatic accounts.
- 3. Just Clean Fuel, LLC shall not be responsible for any delay or failure to deliver product due to embargos, shortages, acts of terrorism, acts or regulations of any government authority, governmental rationing, strikes, war conditions, acts of God or other causes potentially beyond the control of Just Clean Fuel, LLC.
- 4. The customer agrees to pay interest at the rate of one and one half percent [1.5%] per month for all past due balances. The account is past due after 30 days. The customer agrees to pay for any collection fees, including attorney's fees. There will be a \$25.00 fee for any returned check. Automatic delivery accounts will be put on delivery hold for past due payments over 30 days.
- 5. Any purchase of home heating oil from another company will result in the cancellation of the Agreement.
- 6. The customer agrees to terminate any PRE-EXISTING automatic delivery agreements <u>IN WRITING</u> with other fuel oil companies.
- 7. Non-Negotiable Payment Terms for Automatic Deliveries: PAYMENT is due 10 days from the date of delivery.

  All automatic accounts must keep a valid credit card on file. Accounts set up with credit cards for payment will be processed the following business day. An account will be considered past due if payment is not received by the 30th day after the delivery.
  - Customer authorizes the use of the credit card on file if payment is not received within 60 days.
- 8. We will not be responsible for any type of system or property damage in the event the customer runs out of oil due to non-payment under the terms as stated herein.
- 9. <u>Your account will be subject to a \$200 early termination fee should you cancel your account within 12 months or fail to pay your bill within the agreed upon terms. Your balance will be due immediately.</u>
- 10. THIS AGREEMENT WILL AUTOMATICALLY RENEW AND DELIVERIES WILL CONTINUE EACH YEAR. CUSTOMER MUST NOTIFY JUST CLEAN FUEL IN WRITING TO TERMINATE ACCOUNT.
